Biography

After clerking for the Chief Judge of the Eighth Circuit Court of Appeals, Roger Stone joined the firm in 1981. He soon began litigating commercial and construction cases across Iowa. He has led the firm's efforts to build a strong reputation and practice in the fields of [construction](#) and [environmental law](#). Mr. Stone has represented many corporations, contractors, cities, counties, engineers, architects and individuals in hundreds of cases for over forty years. He has handled claims of up to \$2.2 billion.

Attorney General Tom Miller selected Mr. Stone and Simmons Perrine as the only lawyer and firm outside of Des Moines to serve as Special State Counsel to represent the State against the tobacco companies. Among other activities, Mr. Stone argued the case in the Supreme Court of Iowa. Iowa and other states successfully settled their claims in late 1998, resulting in the largest recovery in the State's history of over \$2.2 billion and substantial health related programs.

He acts as general counsel to general, roofing, mechanical, electrical, excavation, concrete, masonry, paving, painting, drywall and other contractors and architect and engineering firms.

Mr. Stone has served as an arbitrator on the American Arbitration Association's national panel of construction arbitrators for large complex cases, including 40 panels of three arbitrators and 45 single arbitrator cases. The cases have involved claims of up to \$100 million. Mr. Stone has served as counsel representing clients in many construction arbitrations that have gone to hearing and also serves as a mediator in construction cases throughout Iowa.

Mr. Stone has also managed superfund matters, chemical spills, permitting issues, delay and disruption claims, contaminated land sales, remediation plans, criminal defense of corporate officers and water and wastewater issues.

Mr. Stone spent 25 years serving as Managing Partner and Chair of the Board of Directors of the firm.
